Big Donors To Governor Perry Tutor *El Presidente Mexicano* *En La Democracia Americana*

Loyal Knights Invited to Vicente Fox's "Business Roundtable" Paid \$3 Million in Tribute to Texas Governor and His Party

Austin—In inviting top campaign contributors to an exclusive "Business Roundtable" meeting today with Mexican President Vicente Fox, Texas Governor Rick Perry gave Mexico's first opposition-party president a \$3 million lesson in American-style democracy.

All 33 of Governor Perry's invitees to the roundtable were Texas business executives except for U.S. Ambassador to Mexico Tony Garza. Since Perry became governor in December 2000, he and the Texas Republican Party have received \$3 million in contributions from 28 of the 32 business invitees and/or their companies.

"This patronage system is enough to qualify Governor Perry for an honorary membership in the PRI Party that ruled Mexico for 71 years," said Texans for Public Justice Director Craig McDonald.
