Three San Antonio Politicos Gone Loco for Tobacco

☹ **3 San Antonio Reps -- Corte, Shields & Siebert -- Tarred By
Voting A Straight Tobacco-Industry Ticket on Kids Protection Bill**

☺ **38 House Members Vote for Human Health At Every Opportunity**

Austin—Three Republican House members from San Antonio were among seventeen members of the Texas House who turned their backs on consumer and health interests by consistently voting with the powerful tobacco lobby on four key votes in the last days of the 75th Legislative session, according to “Smoke in the Mirror: How Texas House Members Voted on Tobacco-Control Legislation,” a new 6-page Texans for Public Justice report.

The tarred members -- Representatives Corte, Shields and Siebert -- proved their true colors by voting for four key amendments that were designed to undermine two major tobacco-control bills: the Childrens’ Access to Tobacco Bill (SB 55); and the Cigarette Ingredients Disclosure Bill (HB 119). Despite these sabotage attempts, the bills prevailed thanks to 38 House members, who consistently voted for consumer health.

“Voters should take note of the “tobacco locos” who voted a straight tobacco-lobby ticket and consider relegating them to the ash tray of history,” said Craig McDonald, director of Texans for Public Justice. “They would sacrifice the health of our children for the tobacco barons. But Texans draw the line when it comes to selling deadly drugs to our kids.”

“The 38 House members who stood up to the powerful tobacco lobby deserve the praise of every Texan who cares about the health of our children,” McDonald said.

The only prevailing pro-tobacco amendment, offered by **Rep. Warren Chisum** (R-Pampa), was an HB 119 loophole that prevents tobacco companies from having to disclose what toxins and other ingredients they roll into their products. Chisum also offered three failed amendments to

sabotage the Childrens' Access Bill. **Rep. John Shields** (R-S.A.) rode shotgun as the co-sponsor of one such amendment, which would have stripped the bill of enforcement funds.

“Smoke in the Mirror” reveals that the House tobacco votes broke along strikingly partisan lines:

- Of the 38 legislators who backed the pro-health position on all four amendments, only one is a Republican: **Ron Clark of Sherman** ; and
- Of the 17 legislators who supported all four health sabotage amendments, only one is a Democrat: **Tom Uher of Bay City** .

The report calculates a “health rating” for each House member by dividing the number of pro-health votes a member cast by four—the total number of tobacco-related votes analyzed. **The average pro-health rating for House Democrats was 77%, while the health rating for House Republicans was 31%.**
